Payment Deadlines

The UNT Dallas College of Law provides the following alternatives for the payment of tuition and fees:

Early Registration Payment Deadline	Friday, July 31
Regular Registration Payment Deadline.....	Friday, August 21
Late Registration Payment Deadline.....	Wednesday, August 26

Full payment of tuition and fees are required upon registration or by the payment deadlines listed below.

Payment for any additional fees resulting from Schedule Revision or Add/Drops is due by Census Day for the term.

Installment Payment Plan (Effective Fall 2015)

First installment payment deadline (10%)	August 1
Second installment payment deadline (30%)	October 3
Third installment payment deadline (30%)	November 3
Fourth installment payment deadline (30%)	December 3

NOTE: A \$20 fee is added when the installment plan is processed and is due with the initial payment.

Refund Schedule

Refunds for dropping or withdrawing from the College of Law will be generated once classes begin.

The amount depends on whether or not you remain enrolled in other courses. The refund policy is based on Texas state law and can be found under [Section 54.006](#) of the Education code of the Texas Statutes.

Dropping a Course(s)

If you drop a course(s) but remain in at least one other course, you will receive a 100% refund until the following dates:

If you drop or withdraw from all your courses for the semester, the following refund schedule applies to you:
